RESOLUTION NO. 1404

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO SET ASIDE THE SUM  
OF TWENTY-FIVE THOUSAND PESOS (P25,000.00) OUT OF THE 20%  
ECONOMIC DEVELOPMENT FUND FOR ORMOC CITY'S PARTICIPATION IN  
THE AGRO-INDUSTRIAL FAIR IN CONNECTION WITH THE TACLOBAN  
CITY FIESTA '83, PURSUANT TO MLG MEMORANDUM CIRCULAR 83-09

"WHEREAS, the City of Ormoc is participating in the Agro-Indus-  
trial Fair by putting up displays of products indigenous to the pro-  
vince and other materials depicting the progress of Ormoc City in a  
booth provided the city free of rent, in which connection we can use  
a portion of our 20% Economic Development Fund for incidental expenses  
that may be incurred appertaining to the putting up of display materials;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unanimo-  
usly by all the other Mga Kagawad present; be it

"RESOLVED, to authorize the City Treasurer to set aside the sum  
of TWENTY-FIVE THOUSAND PESOS (P25,000.00) out of the 20% Economic De-  
velopment Fund, said sum or so much thereof as may be necessary to be  
made available for Ormoc City's participation in the Agro-Industrial  
Fair in connection with the Tacloban City Fiesta '83, pursuant to Me-  
morandum Circular No. 83-09 dated May 31, 1983, of the Ministry of  
Local Government Assistant Regional Director; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
Madam Imelda Romualdez-Marcos, Hermana Mayor, Fiesta '83, Her Honor,  
Mayor Abdulia R. Cinco, and Mr. Edilberto V. Roa, Assistant Regional  
Director, Ministry of Local Government, all in Tacloban City; the City  
Treasurer and the City Budget Officer, both in Ormoc City;
