RESOLUTION NO. 1405

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST THE
CURRENT APPROPRIATION ON ROAD RIGHT OF WAY ACQUISITION THE SUM
OF P34,000.00 TO SETTLE OUTSTANDING OBLIGATIONS WITH THE HIJOS
DE F. ESCAÑO FOR 170 SQUARE METERS @ P200.00 OF LOTS 535, 534,
AND 533 AFFECTED BY THE WIDENING OF REAL AND BURGOS STREETS
SUBJECT, HOWEVER, TO TAX OBLIGATIONS OF THE COMPANY.

"WHEREAS, the City Assessor in his return indorsement dated June
8, 1983, has informed that the price then obtaining at the time of ac-
quisition by the City of 170 square meters of Lots 535, 534 and 533 of
the Hijos de F. Escaño affected by the widening of Real and Burgos
streets as of 1980 was P200.00 per square meter such that the City is
obligated to the company by P34,000.00;

"WHEREAS, the City Assessor has also informed that Lots Nos. 535
and 534 have no existing tax declarations, hence, no taxes were paid;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Ka-
gawad Mendola; be it

"RESOLVED, to authorize the City Treasurer to charge against the
current appropriation on Acquisition of Road Right of Way the sum of
Thirty-Four Thousand Pesos (P34,000.00) to be made available for set-
tling outstanding obligations with the Hijos de F. Escaño for 170 sq.
meters @ P200.00 of Lots Nos. 535, 534, and 533 affected by the widen-
ing of Real and Burgos streets subject, however, to tax obligations of
the Hijos de F. Escaño; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Mr. Dennis A. Garcia, Vice-President, Hijos de F. Escaño, Inc., P.O.
Box 205, Cebu City; the City Treasurer, the City Assessor, the City
Engineer and the City Budget Officer, all in Ormoc City;
