RESOLUTION NO. 1407

A RESOLUTION INTERPOSING NO OBJECTION TO THE LOCAL MSSD'S SPONSORSHIP OF A 3-DAY "PINTAKASI" (JULY 28-30, 1983) AT THE MADUNGHOLAN COCKPIT PROVIDED THEY COMPLY WITH THE RULES AND REGULATIONS OF THE PHILIPPINE GAMEFOWL COMMISSION.

"WHEREAS, the Officer In Charge of the Ministry of Social Services and Development (MSSD), Ormoc City Branch, has requested a resolution to allow them to sponsor a 3-day 'pintakasi' on July 28-30, 1983, at the Madungholan Cockpit, a licensed establishment in Ormoc City, the proceeds of which will be appropriated for drought victims and for other emergency cases;

"WHEREAS, we find the request of the MSSD Officer In-Charge laudable and worthy of our consideration inasmuch as it will benefit mostly the unfortunate and the needy;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded jointly by Hon Kagawad Mendola and Bandalan; be it

"RESOLVED, to interpose no objection to the local MSSD's sponsorship of a 3-day 'pintakasi' on July 28, 29 and 30, 1983, at the Madungholan Cockpit provided, however, that they comply with the rules and regulations promulgated by the Philippine Gamefowl Commission; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Philippine Gamefowl Commission, Tacloban; the Station Commander, Integrated National Police, the Officer In Charge, MSSD, and the General Manager, Madungholan Cockpit, all in the City of Ormoc;
