A RESOLUTION TO RATIFY THE AGREEMENT BETWEEN THE HONORABLE CITY  
MAYOR AND THE GEODETIC ENGINEER FOR THE CONSOLIDATION SURVEY  
AND TITLING OF GOVERNMENT CENTER LOTS, PURSUANT TO COURT OF  
APPEALS DECISION, INCLUDING THOSE LOTS ACQUIRED BY THE CITY  
THROUGH NEGOTIATED PURCHASE.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Men-  
dola, seconded jointly by Mga Kagawad Torrevillas and Hermosilla;

"RESOLVED, to ratify the agreement between the City of Ormoc,  
represented by His Honor, Mayor Iñaki A. Larrazabal, and the private  
geodetic engineer, Mr. Venancio G. Besavilla, for the consolidation  
survey and titling of government lots consisting of twenty-three (23)  
parcels, pursuant to the decision of the Honorable Court of Appeals  
in CA-G.R. No. 50652-R (Sp. Civil Case No. 711-0) for eminent domain,  
as well as those lots acquired by the city through negotiated purchase,  
all in the government center site of Ormoc City; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the City Legal Officer, the City Treasurer, the City Engineer, the  
Judge of the Regional Trial Court, and the private Geodetic Engineer  
(Venancio G. Besavilla), all in Ormoc City;
