RESOLUTION NO. 1422

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO DONATE LOT NO. 2-PART COVERED BY T.C.T. NO. 11335-PART UNDER TAX DECLARATION NO. 107167 CONTAINING 1 HECTARE FOR PURPOSES OF A COMMUNITY SCHOOL SITE OF BARANGAY DOÑA FELIZA MEJIA TO THE HONORABLE MINISTRY OF EDUCATION, CULTURE AND SPORTS PROVIDED THAT SHOULD THE MINISTRY HAVE NO MORE USE FOR THE LOT, THE SAME AND ALL THE IMPROVEMENTS THEREON SHALL REVERT TO THE CITY

"WHEREAS, this august Body will remember Doña Feliza Z. Mejia to have donated one hectare of her lot in Barangay Toog (now Doña Feliza Z. Mejia) to the City Government which for purposes of a community school site is now designated as Lot No. 2-part covered by Transfer Certificate of Title No. 11335-part under Tax Declaration No. 107167;

"WHEREAS, being a school site, this Body finds it proper to donate this lot to the Ministry of Education, Culture and Sports for as long as the latter would use it, otherwise, the same and all the improvements thereon shall revert to the City of Ormoc;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Besabella and Santiago; be it

"RESOLVED, to authorize the Honorable City Mayor to donate Lot No. 2-part covered by T.C.T. No. 11335-part under Tax Declaration No. 107167 containing an area of one hectare situated in Barangay Doña Feliza Z. Mejia to the Honorable Ministry of Education, Culture and Sports for purposes of a community school site provided, however, that should the Ministry have no more use for the lot, the same and all improvements thereon shall revert to the City of Ormoc; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Education, Culture and Sports, Metro Manila; the Regional Director, Ministry of Education, Culture and Sports, Tacloban City; the Division Superintendent of City Schools, the City Legal Officer, the City Treasurer, the City Assessor, and the Punong Barangay of Doña Feliza Z. Mejia, all in Ormoc City;

"CARRIED UNANIMOUSLY."
