RESOLUTION NO. 1423

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL AND PROVINCIAL PC-
INP COMMANDERS TO AUGMENT THE PRESENT POLICE FORCE IN ORMOC CITY
BASED ON ITS POPULATION OF ONE HUNDRED TWENTY THOUSAND (120,000)

"WHEREAS, before the integration when Ormoc City had only a popu-
lation of some 100,000 there were more or less 95 policemen and now
that the population has swollen to 120,000 the force has been reduced
to only 65 policemen such that thieveries, vandalism, gambling and
other criminal acts are becoming almost always uncontrollable to the
detriment of life and property, peace and order, safety and security
of the city;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded una-
nimously by all the other Mga Kagawad present; be it

"BE IT RESOLVED, to earnestly request the Regional and Provincial
PC-INP Commanders to augment the present police force in Ormoc City
based on its population of one hundred twenty thousand (120,000); and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Brig. Gen. Cesar Villarin, Regional Commander, PC-INP, Camp September
21st, Kampitik, Palo, Leyte; Col. Vicente Garcia, Provincial Commander,
PC-INP, Port Area, Bonifacio Road, Tacloban City; and Maj. Alfredo T.
Quibin, Station Commander, OCINP, Ormoc City;
