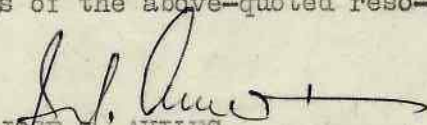
"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torre Villas; be it

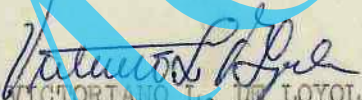
