RESOLUTION NO. 1425

A RESOLUTION AUTHORIZING THE CITY LEGAL OFFICER TO CAUSE THE
EJECTION OF THE FOUR (4) SQUATTERS ON THE COMMUNITY SCHOOL
SITE OF BARANGAY LINAO TO GIVE WAY TO THE CONSTRUCTION OF
THE BAGONG LIPUNAN SCHOOL BUILDING.

"WHEREAS, the Punong Barangay of Linao had sought the assistance
of this august Body by way of ejecting the four (4) squatters, namely:
Bartolome Cabaca, Constantino Madjus, Sr., Felix Suchisa and Angel Sa-
ban on the community school site in order not to hamper the construc-
tion of the three-room Bagong Lipunan school building;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by
Kagawad Bandalan; be it

"RESOLVED, to authorize the City Legal Officer to cause the ejec-
tion of the four (4) squatters on the community school site of Baran-
gay Linao to give way to the construction of the Bagong Lipunan school
building; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Legal Officer, the City Engineer, the Punong Barangay and the
School Principal of Barangay Linao, and all the squatters concerned,
Barangay Linao, Ormoc City;

"CARRIED UNANIMOUSLY."
