RESOLUTION NO. 1427

A RESOLUTION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, THE
PRESIDENT, AND THE FIRST LADY, TO KINDLY INTERCEDE FOR THE
LEYTE ELECTRICITY CONSUMERS WITH THE NATIONAL POWER CORPO-
RATION TO ROLL BACK AND NOT TO INCREASE THE ENERGY CHARGES

"WHEREAS, the NPC National Power Board had served notice that it
had fixed and approved new electricity rates schedules for the diffe-
rent grids effective July 26, 1983, and for that matter had extended
the fuel cost adjustment (FOA) to include the steam cost adjustment
(SCA) and coal cost adjustment (CCA), thus affecting the Leyte Grid
which has a geothermal power source but being charged higher rates
than its counterpart in Luzon and Negros Oriental having geothermal
and other power sources which are more expensive to operate than
that of Leyte Grid;

"WHEREAS, this notice in effect serves as a denial of our request
embodied in Resolution No. 1374 for a roll back of rates based on the
geothermal power after the power barge had already been withdrawn last
May 30, 1983, such that it behooves this august Body to turn for assis-
tance to the President and the First Lady that they may intercede for
the Leyte power consumers to be charged the least with the view to
rolling back and not increasing the energy charges;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly
by all the other Mga Kagawad present; be it

"RESOLVED, To most respectfully request His Excellency, the Pre-
sident, and the First Lady to kindly intercede for and in behalf of
the Leyte electricity consumers with the National Power Corporation
to roll back and not to increase the energy charges; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to His Excellency, President Ferdinand E. Marcos, and the Honorable
Imelda Romualdez-Marcos, both in Malacañang, and Hon. Gabriel Y. It-
chon, President, National Power Corporation, Quezon Ave. cor. BIR
Road, Diliman, Q.C., all in Metro Manila; and the General Manager and
the Board President, both of LEYECO V, in Ormoc City;

"CARRIED UNANIMOUSLY."
