MENT FUND TO BE MADE AVAILABLE FOR FINANCIAL ASSISTANCE TO  
THE BALIKATAN NG KAUNLARAN MOVEMENT, ORMOG CITY CHAPTER.

"WHEREAS, the President of the Ormoc City Chapter of the Balika-
