(RCPI), in his communication of August 15, 1983, has requested this august Body to possibly pass a resolution, being a requisite, to open its long distance telephone service to assist other communications enterprises which cannot cope up with the demand of numerous callers in the City of Ormoc;

"WHEREAS, we find the request of the Station Manager most worthy of consideration and, for that matter, we can even include any other company to open a long distance telephone service in Ormoc City;
