RESOLUTION NO. 1450

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY OF VALENCIA TO
AVAIL OF THE CITY LOT OCCUPIED BY INP SUB-STATION NO. 212, INP
FIRE SUB-STATION NO. 2, AND BARANGAY HEALTH CENTER FOR PURPOSES
OF A SCHOOL SITE OF THE MATAAS NA PAARALAN NG VALENCIA (VALENCIA
BARANGAY HIGH SCHOOL).

"WHEREAS, the Sangguniang Barangay of Valencia in its Resolution
No. 14, current series, has requested this august Body to allow them
to use the city lot in said barangay occupied by the INP Sub-station
No. 212, the INP Sub-Fire Station No. 2, and the barangay health cen-
ter for the site of the Mataas na Paaralan ng Valencia (Valencia Ba-
rangay High School);

"WHEREAS, this city lot has been acquired by the government for
purposes of the Ormoc City High School site in the late forties and,
considering the memorandum of the Ministry of Education, Culture and
Sports requiring all barangay high schools to have their own sites,
this Honorable Body interposes no objection to the use of this lot
by the Valencia Barangay High School;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly
by Mga Kagawad Tugonon and Hermosilla; be it

"RESOLVED, to authorize the Sangguniang Barangay of Valencia to
avail of the city lot occupied by the INP Sub-station No. 212, INP
Sub-Fire Station No. 2, and the barangay health center for purposes
of a school site of the Mataas na Paaralan ng Valencia (Valencia Ba-
rangay High School); and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Sangguniang Barangay of Valencia, the Principal of Valencia
Barangay High School, the Station Commander, INP, the Station Com-
mander, INP-Fire Services, and the City Health Officer, all in Or-
moc City;
