RESOLUTION NO. 1451

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) OUT OF THE ITEM ON INVESTIGATION AND SURVEY TO BE MADE AVAILABLE FOR ORMOG CITY'S SHARE OF EXPENSES IN THE SURVEY AND RELOCATION OF THE ORMOG-ALBUERA BOUNDARY.

"WHEREAS, the Honorable Municipal Mayor of Albura, Leyte, in a letter to the ad hoc committee chairman dated September 7, 1983, has signified his intention to start the survey of the Ormoc-Albuera boundary with the Bureau of Lands Survey Party on September 19, 1983, until the task is completed in two weeks which will cost P5,000.00;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Tugonon and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of Two Thousand Five Hundred Pesos (P2,500.00) out of the item on Investigation and Survey, said sum or so much thereof as may be necessary to be made available for Ormoc City's share of expenses in the survey and relocation of the Ormoc-Albuera boundary; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, the Mayor of Albura, Leyte; the Chief, Surveys Division, Bureau of Lands, Tacloban City; the Chief, Survey Party, Bureau of Lands, Albura, Leyte; the Geodetic Engineer, Office of the City Engineer, and the Punong Barangay (Mr. Benjamin Imbayarte) of Liberty, both in Ormoc City;
