"WHEREAS, in passing Resolution No. 1424 this august Body inadvertently included the names of some nine (9) occupants of the area in excess of Lot No. 2222 in the list of squatters on the Government Center Site with which we authorized the City Legal Officer to file with the Regional Trial Court the necessary motion asking for an alias writ of execution against the squatters in connection with C.A.G.R. "NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Bandalan; be it
