"WHEREAS, this august Body concurs in the embodiment of the resolution of the Dipolog Sanggunian considering the disparity in the granting of gasoline and representation allowances to department or office heads but leaving alone Members of Sangguniang Panlungsod who are always the first people approached by indigent persons and civic clubs for some contributions;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Codilla; be it

"RESOLVED, to adopt Resolution No. 407 of the Honorable Sangguniang Panlungsod ng Dipolog and do, as this Body hereby does, earnestly request the Joint Commission on Local Government Personnel Administration to allow Members of the Sangguniang Panlungsod all over the country to collect representation allowances and gasoline allowances; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Gaudioso C. Sosmeña, Jr., Executive Secretary (Director), Bureau of Local Government, Victoria I Bldg., Corner Bohol and Quezon Avenues, Quezon City, and the Honorable Sangguniang Panlungsod, City of Dipolog;
