A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE
DEED OF SALE WITH THE HIJOS DE F. ESCAÑO COVERING 170 SQUARE
METERS OF THE LATTER'S LOTS 535, 534 AND 533 AFFECTED BY THE
WIDENING OF REAL AND BURGOS STREETS, PER RESOLUTION NO. 1405

"WHEREAS, this august Body passed Resolution No. 1405 on June 21,
1983, authorizing the City Treasurer to settle outstanding obligations
with the Hijos de F. Escaño amounting to P34,000.00 for 170 square me-
