RESOLUTION NO. 1459

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF TWO (2) 60-WATT MERCURY VAPOR LAMPS BY THE SANG-
GUNSIANG BARANGAY OF SANGGUNIANG 16 FOR REPLACEMENT OF THE
BUSTED LAMPS ON POSTS NO. AD3 AND NO. AD6 ON AGUADULCE STREET
SUBJECT TO INSPECTION AND VERIFICATION BY THE CITY ELECTRICAL
ENGINEER.

"WHEREAS, the Sangguniang Barangay of Barangay 16 by its Resolu-
tion No. 19 current series, has signified their intention to donate
two units of 60-watt mercury vapor lamps with which they would like
to replace the busted electric lamps on Post Nos. AD3 and AD6 along
Aguadulce Street being within the jurisdiction of the said barangay;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kaga-
wad Santiago; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the
donation of two (2) units of 60-watt mercury vapor lamps by the Sang-
guniang Barangay of Sangguniang 16 to be made available for replace-
ment of the busted lamps on Posts No. AD3 and No. AD6 on Aguadulce
Street subject, however, to inspection and verification by the City
Electrical Engineer; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Punong Barangay, Barangay 16, the General Manager, LEVICO V,
the City Treasurer, and the City Electrical Engineer, all in Ormoc
City;
