CONTRACT WITH THE PHILIPPINE RIGID CONSTRUCTION CORPORATION
FOR EXTRA WORK ORDER FOR ADDITIONAL CONSTRUCTION OF SIDEWALKS,
PARKING AREA AND DRAINAGE OF THE SHOPPING MALL.

"WHEREAS, with the nearing completion of the first phase of the
Shopping Mall construction by the Philippine Rigid Construction Cor-
poration it has become necessary that an extra work order has had to
be made pertinent to the construction of sidewalks, parking area and
drainage of the said shopping mall;
