RESOLUTION NO. 1463

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF SEVEN THOUSAND FIVE HUNDRED PESOS (P7,500.00) FROM OUT OF THE 20% DEVELOPMENT FUND TO BE MADE AVAILABLE FOR FINANCIAL AID TO THE 1983 OCTOBER 29-30 FKB LIVE-IN LEADERSHIP TRAINING SEMINAR AS AUTHORIZED BY THE MINISTRY OF LOCAL GOVERNMENT.

"WHEREAS, the Honorable Ma. Emily C. Codilla, President, Federation of Kabataang Barangays (FKB), reported that the Federation will conduct a live-in leadership training seminar come October 29-30 at the City Central School building for which she asked for an appropriation of Seven Thousand Five Hundred Pesos (P7,500.00) out of the 20% Development Fund as authorized by the Ministry of Local Government;

"NOW, THEREFORE, on motion of Kagawad Codilla, seconded jointly by Mga Kagawad Tugonon and Torrevillas; be it

"RESOLVED, to authorize the City Treasurer to release the sum of SEVEN THOUSAND FIVE HUNDRED PESOS (P7,500.00) from out of the 20% Development Fund, said sum or so much thereof as may be necessary to be made available for financial aid to the 1983 October 29-30 live-in Leadership Training Seminar of the Ormoc City Federation of Kabataang Barangays as authorized by the Ministry of Local Government; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the City Development Officer, and the Honorable M. Emily C. Codilla, FKB President, all in Ormoc City;
