RESOLUTION NO. 1464-A

A RESOLUTION EARNESTLY REQUESTING THE OFFICE OF BUDGET AND MANAGEMENT TO AUTHORIZE ORMOG CITY TO EXCEED ITS 1984 GENERAL FUND ANNUAL BUDGET BEYOND THE 45% ALLOWABLE MAXIMUM BUT STILL WELL WITHIN THE 25% ALLOWABLE EXCESS IN THE PROVISION FOR SALARIES AND WAGES FOR FIRST CLASS CITIES.

"WHEREAS, in the recently approved 1984 Ormoc City General Fund Annual Budget the provision for salaries and wages has aggregated to ₱2,786,483.80 which amount is already beyond the 45% allowable maximum by ₱226,495.22 but which is still very well within the 25% allowable excess for First Class Cities as it is only 8%;

"WHEREAS, the excess is due to the implementation of a general one-step salary increase under Budget Circulars Nos. 11 and 15 including 84 vacant positions whose salaries and wages aggregate in the sum of ₱776,309.60 which the City does not intend yet to fill up in line with its cost cutting program which ultimately will rebound to a huge savings;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Office of Budget and Management to authorize Ormoc City to exceed its 1984 General Fund Annual Budget beyond the 45% allowable maximum but still very well within the 25% allowable excess in the provision for salaries and wages for First Class Cities; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each, through the City Budget Officer, to the Office of Budget and Management and the Regional Director, Ministry of the Budget;

"CARRIED UNANIMOUSLY."
