RESOLUTION NO. 1466

A RESOLUTION ADOPTING RESOLUTION NO. 911-83 OF THE HONORABLE SANGGUNIAN NG PANLUNGSOD NG PUERTO PRINCESA ENDORSING AND SUPPORTING RESOLUTION NO. 1911 OF THE HONORABLE SANGGUNIAN NG PANLUNGSOD NG LUCENA WITH PROVISION FOR CLASSIFICATION OF CITIES ACCORDING TO THREE CATEGORIES.

"WHEREAS, the Honorable Sangguniang Panlungsod ng Puerto Princesa has furnished a copy for our adoption of its Resolution No. 911-83 endorsing and supporting Resolution No. 1911 of the Honorable Sangguniang Panlungsod ng Lucena with provision for the classification of cities in accordance with the three categories;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Santiago; be it

"RESOLVED, to adopt Resolution No. 911-83 of the Honorable Sangguniang Panlungsod ng Puerto Princesa endorsing and supporting Resolution No. 1911 of the Honorable Sangguniang Panlungsod ng Lucena and do, as this Body hereby does, earnestly request His Excellency, the President of the Philippines or the Batasang Pambansa to amend Section 166 of Batas Pambansa Blg. 337, otherwise known as the Local Government Code; PROVIDED, HOWEVER, that the classification of cities shall be made in accordance with the three categories, namely:

- a) Highly Urbanized Cities - cities with a population of more than 150,000 and annual income of more than ₱50,000,000.00;
- b) Urbanized Cities - cities with a population of not less than 50,000 but not more than 150,000 and annual income of ₱15,000,000.00 to ₱50,000,000.00; and
- c) Component Cities - cities with a population of less than 50,000 and annual income of less than ₱15,000,000.00;
