RESOLUTION NO. 1467

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE GOVERNOR BENJAMIN ROMUALDEZ THAT THE ₱20,000.00 SPECIAL KKK FUND PER BARANGAY OF ORMOC CITY BE UNDERTAKEN BY THE ASSOCIATION OF BARANGAY COUNCILS AND SUBJECT TO THE DISPOSAL TO THE BARANGAYS BY THE CITY MAYOR, THE CITY TREASURER, THE CITY KKK ACTION OFFICER, AND THE ABC PRESIDENT THROUGH SIMPLIFIED PAPER/DOCUMENT REQUIREMENTS.

"WHEREAS, there is being earmarked for every barangay a special KKK fund in the sum of Twenty Thousand Pesos (₱20,000.00) which this august Body believes will be properly administered, once released, if the fund will be undertaken by the Association of Barangay Councils depositing the same with the Office of the City Treasurer and be disposed only to the 109 barangays with the sanction of the City Mayor, the City Treasurer, the City KKK Action Officer, and the ABC President;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Samson; be it

"RESOLVED, to earnestly request the Honorable Governor Benjamin Romualdez of Leyte that the ₱20,000.00 Special KKK Fund per barangay of Ormoc City be undertaken by the Association of Barangay Councils and shall be subject to the disposal to the barangays by the City Mayor, the City Treasurer, the City KKK Action Officer, and the ABC President; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Governor Benjamin Romualdez, Tacloban City; the City Treasurer, the City KKK Action Officer, and the ABC President, all in Ormoc City;

"CARRIED UNANIMOUSLY."
