A RESOLUTION EARNESTLY REQUESTING MAJ. GEN. FIDEL V. RAMOS AN
ALLOCATION OF TWO (2) MINI LAND CRUISER SERVICE VEHICLES
FOR THE USE OF THE ORMOC CITY POLICE FORCE

"WHEREAS, the Ormoc City Police Force has only one unit of mini
land cruiser service vehicle which is quite inadequate considering
that it serves 109 barangays and a city population of 125,000 more
or less;

"WHEREAS, to be an effective law-enforcing agency the Ormoc City
Police Force ought to have at least two more units for more conveni-
ent and speedy mobility of patrols;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded by
Kagawad Bessabella; be it

"RESOLVED, to earnestly request Maj. Gen. Fidel V. Ramos an allo-
cation of two (2) units of mini land cruiser service vehicles for the
use of the Ormoc City Police Force; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Brig. Gen. Fidel V. Ramos, Director General, Integrated National Police,
Camp Crane, Cueson City, and the Station Commander, INP, Ormoc City;
