RESOLUTION NO. 1474

A RESOLUTION TO REQUEST THE CITY POSTMASTER TO ESTABLISH SERVICE
OUTLETS IN THE CITY PROPER FOR BETTER SERVICE TO THE PEOPLE
IN THEIR POSTAL NEEDS.

"WHEREAS, with the transfer of the post office to the government
center the people in the city proper find it quite inconvenient to
mail letters and packages even as they spend P1.50 for transporta-
tion back and forth just to mail an ordinary letter stamped at forty
centavos, such that there is now a popular clamor for service outlets
in strategic places in the poblacion in order that the people's pos-
tal needs could better be served;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimous-
ly by all the other Mga Kagawad; be it

"RESOLVED, to request the City Postmaster to establish service
outlets in the city proper for better service to the people in their
postal needs; and be it

"RESOLVED, FURTHER, to furnish; a copy of this resolution each
to the City Postmaster and the President, Association of Barangay
Councils, both in Ormoc City;

"CARRIED UNANIMOUSLY."
