RESOLUTION NO. 1475

A RESOLUTION INTERPOSING NO OBJECTION TO THE ORMOC CITY SOUTH DISTRICT SCOUTING COMMITTEE'S SPONSORSHIP OF A 3-DAY "PINTAKASI" (DECEMBER 22-24, 1983) AT THE NADUNGOLAN COCKPIT PROVIDED THEY COMPLY WITH THE RULES AND REGULATIONS OF THE PHILIPPINE GAMEFOWL COMMISSION.

"WHEREAS, the Vice-President of the South District Scouting Committee, this city, in his letter dated October 17, 1983, has requested a resolution to allow them to sponsor a 3-day 'pintakasi' on December 22, 23 and 24, 1983, at the Nadungholan Cockpit, a licensed establishment, the proceeds of which will be appropriated for the various scouting activities and projects;

"WHEREAS, we find the request laudable and worthy of our consideration inasmuch as it will go a long way towards the youth development;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the other Kagawad; be it

"RESOLVED, to interpose no objection to the Ormoc City South District Scouting Committee's sponsorship of a 3-day 'pintakasi' on December 22, 23 and 24, 1983, provided, however, that they comply with the rules and regulations promulgated by the Philippine Gamefowl Commission;
