RESOLUTION NO. 1479

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN AN AGREEMENT WITH THE MLG RURAL ROADS PROGRAM (RRP) FOR PURPOSES OF A RURAL DEVELOPMENT LOAN FOR THE ACQUISITION AND PURCHASE OF BRAND NEW MAINTENANCE EQUIPMENT TO BE ALLOCATED ON A PROGRAMMED-AMORTIZATION SCHEME TO THE CITY OF ORMOC.

"WHEREAS, the City of Ormoc would like to avail itself of the Rural Development Loan through the Rural Roads Program of the Ministry of Local Government (MLG/RRP) to be made available for acquisition and purchase of brand new maintenance equipment such as 1 grader, 1 vibratory roller and 1 payload to be allocated on a programmed-amortization scheme for which an AGREEMENT has got to be entered into by the Ministry of Local Government and the City of Ormoc;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in behalf of the City of Ormoc, to sign an AGREEMENT with the MLG Rural Roads Program (RRP) for purposes of a Rural Development Loan for the acquisition and purchase of brand new maintenance equipment to be allocated on a programmed-amortization scheme to the City of Ormoc; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Salvador P. Socrates, Deputy Minister of Local Government, Metro Manila; the Regional Director, Ministry of Local Government, Region VIII, Tacloban City; the City Engineer, and the City Development Officer, both in Ormoc City;
