RESOLUTION NO. 1481

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO RELEASE THE SUM OF ONE THOUSAND FIVE HUNDRED PESOS OUT OF THE BARANGAY DEVELOPMENT FUND AND/OR 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE FOR FINANCIAL AID TO BARANGAY AIRPORT FOR SCHOOL SITE ACQUISITION

"WHEREAS, the Punong Barangay of Airport in her letter of November 25, 1983, has requested financial assistance in the amount of One Thousand Five Hundred Pesos (P1,500.00) to supplement the funds they raised for the purpose of acquiring a community school site;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Torrevillas, Bandalan and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of One Thousand Five Hundred Pesos (P1,500.00) out of the Barangay Development Fund and/or the 20% Economic Development Fund, said sum or so much thereof as may be necessary to be made available for financial aid to Barangay Airport in the acquisition of a community school site;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, and the Punong Barangay of Airport, all in the City of Ormoc;

"CARRIED UNANIMOUSLY."
