RESOLUTION TO AUTHORIZE THE CITY TREASURER TO RELEASE THE SUM OF
P8,200.00 OUT OF THE ITEM ON ROAD-RIGHT-OF-WAY ACQUISITION TO BE
MADE AVAILABLE FOR PAYMENT FOR 39 SQUARE METERS OF FELISA C. ANGU-
LO'S LOT NOT 515-A ON CORNER RIZAL-AVILES STREETS AFFECTED BY CITY
STREETS WIDENING, INCLUDING REGISTRATION, STAMPS AND NOTARIAL FEES

"WHEREAS, following the appraisal by the Assistant City Assessor,
the City Engineer has recommended an appropriation of Eight Thousand
Two Hundred Pesos (P8,200.00) to pay 39 square meters of Mrs. Felisa
C. Angulo's Lot No. 515-A affected by the widening of corner Rizal-
Aviles streets which payment includes registration, stamps and nota-
rial fees;

"RESOLVED, to authorize the City Treasurer to release the sum of
EIGHT THOUSAND TWO HUNDRED PESOS (P8,200.00) out of the item on Road

lisa C. Angulo's Lot No. 515-A affected by the widening of corner
Rizal-Aviles streets, including registration, stamps and notarial fees;
