RESOLUTION NO. 1486

A RESOLUTION TO REQUEST PASAR CORPORATION TO ALLOW BARANGAY NASUNOGAN TO CONNECT A BARANGAY ROAD FROM THE NEWLY CONSTRUCTED ROAD AT SITIO CABUGAO (PUROK 3) OF BARANGAY SALVACION.

"WHEREAS, the Barangay Sanggunian of Nasunogan in its Resolution No. 9, current series, has requested the intercession of this august Body with the Philippine Associated Smelting and Refining (PASAR) Corporation that they be allowed to connect a barangay road from the newly constructed road of PASAR at Sitio Cabugao (Purok 3) of Barangay Salvacion considering that it will be more accessible than the Juaton-Nasunogan road even as landowners affected are willing to donate portions of their land for the construction of Salvacion-Nasunogan road;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by Kagawad Mendola; be it

"RESOLVED, to endorse Resolution No. 9, current series, of the Sangguniang Barangay of Nasunogan, and do, as this Body hereby does, request PASAR Corporation to allow Barangay Nasunogan to connect a barangay road from the newly constructed road at Sitio Cabugao (Purok 3) of Barangay Salvacion; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Philippine Associated Smelting and Refining (PASAR) Corporation, Isabel, Leyte; the City Engineer and the Sangguniang Barangay of Nasunogan, Ormoc City;
