RESOLUTION NO. 1488

A RESOLUTION AUTHORIZING BARANGAY IPIL TO PROVIDE ITS BARANGAY
HIGHWAY WITH ELECTRICAL INSTALLATIONS FROM ITS BOUNDARY ON
BARANGAY BANTIGUE TO ITS OPPOSITE BOUNDARY ON BARANGAY SAN
ANTONIO AVAILING ITSELF OF ITS 10% REALTY TAX SHARES AND
OTHER SOURCE OF FUND OF THE SAID BARANGAY FOR THE PURPOSE

"WHEREAS, the Sangguniang Barangay of Ipil by its Resolution No.
11-83 is requesting this august Body for electrical installations all
along the barangay highway, boundary to boundary, for the protection
of not only pedestrians but also motor vehicles from mischiefs commit-
ted by unknown individuals stoning tricycles carrying passengers;

"WHEREAS, Barangay Ipil can readily afford these installations
and their maintenance even beyond the 250 wattage limitation at their
expense, pursuant to our Resolution No. 1149 dated April 20, 1982,
considering the huge income from the 10% realty tax shares accruing
to Barangay Ipil;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Besabella, Samson and Hermosilla; be it

"RESOLVED, to authorize Barangay Ipil to provide its provincial
highway with electrical installations from its boundary on Barangay
Bantigue to its opposite boundary on Barangay San Antonio provided
that fund for the purpose shall be availed of from out of the 10%
realty tax shares accruing to Barangay Ipil and/or any other source
of fund of the said barangay; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Treasurer, the City Engineer, the General Manager of
LEYECO V, and the Sangguniang Barangay of Ipil, all in Ormoc City;
"CARRIED UNANIMOUSLY."
