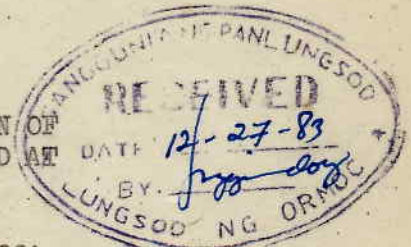

RESOLUTION NO. 1491

A RESOLUTION REQUESTING THE REGISTER OF DEEDS TO CANCEL ENTRIES NOS. 70588 AND 70589 IN TCT NOS. 14663, 14664 AND 14766 FOR LOTS NOS. 2228-D, 2228-G, AND 2228-C, RESPECTIVELY, CONSIDERING THAT THE LOTS, BEING IN EXCESS OF LOTS EXPROPRIATED FOR GOVERNMENT CENTER SITE PURPOSES, HAVE ALREADY BEEN RETURNED TO THE OWNERS FOLLOWING RESOLUTION NO. 77 DATED JUNE 1, 1976

"WHEREAS, in the Transfer Certificates of Title Nos. 14663, 14664 and 14766 for Lots Nos. 2228-D, 2228-G and 2228-C, respectively, there appear Entry No. 70588 in connection with the petition filed by the City Legal Officer for registration of Eminent Domain case resolved in favor of the City Government and Entry No. 70589 appertaining to the CFI Judge's decision affirmed by the Court of Appeals granting the Eminent Domain case in CA-GR No. 50652-R against said lots;

"WHEREAS, by virtue of Resolution No. 77 dated June 1, 1976, of the First Sangguniang Panlungsod, these particular lots, among all others being in excess of Lot No. 2228 expropriated for purposes of the Government Center site, have already been returned to the owners;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Bandalan, Larrazabal and Hermosilla; be it

"RESOLVED, to request the Register of Deeds to cancel Entries Nos. 70588 and 70589 in Transfer Certificates of Title Nos. 14663, 14664 and 14766 for Lots Nos. 2228-D, 2228-G and 2228-C, respectively, considering that the lots, being in excess of Lot No. 2228 expropriated for Government Center Site purposes, have already been returned to the owners following Resolution No. 77 dated June 1, 1976; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Register of Deeds, Mrs. Benita C. Mercado, 152 Real St., and Mr. Ciriaco P. Aviles, Cor. San Pedro-Cataag Sts., all in Ormoc City;
