RESOLUTION NO. 1492

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR, NATIONAL
FOOD AUTHORITY, TO SHIP TO ORMOC CITY SUFFICIENT FLOUR SUPPLY

"WHEREAS, flour dealers and bakers have requested the interces-
sion of this august Body, for and in their behalf, with the Regional
Director of the National Food Authority, inasmuch as the present flour
allocation for Ormoc City is quite not enough and would barely last
for two days even as the demand for this commodity increases every
day;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded una-
nimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Regional Director, National
Food Authority, to ship to Ormoc City sufficient supply of flour to
meet the demands of dealers, bakers and consumers; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Mr. Felixherto D. Roquia, Regional Director, National Food Authority,
Tacloban City, and all bakeries in Ormoc City;
