RESOLUTION NO. 1496

A RESOLUTION MANIFESTING THE DESIRE OF ORMOC CITY, PHILIPPINES,
TO HAVE A SISTERHOOD RELATION WITH THE CITY OF LONG BEACH,
CALIFORNIA, UNITED STATES OF AMERICA

"WHEREAS, it has been a long dream of the City of Ormoc to have a Sister City in the United States of America, among other countries, to where a large number of Ormocans emigrated and settled down;

"WHEREAS, for the realization of such a dream our very own Vice-Mayor and Presiding Officer, the Honorable Jose C. Aviles, during some breaks in his participation in the U.S.A.I.D. Study Grant in Berkeley, California, from July to October of 1981, whiled away his time in search of a Sister City for Ormoc;

"WHEREAS, the Honorable City Mayor has been in receipt of a communication from Dr. Oscar Domondon, an erstwhile resident of Ormoc City in his boyhood and now an American citizen of the City of Long Beach, California, who is affiliated with the Sister Cities International, offering his assistance with the view to seeing Ormoc City as a Sister City to Long Beach and suggesting that we communicate with His Honor, the Mayor of Long Beach, to this effect considering that Ormoc is a beach city just like Long Beach;

"WHEREAS, this august Body would like to avail itself of this opportunity where Dr. Domondon is ready, willing and able to assist us with all his might to effect the Long Beach-Ormoc City Sisterhood process;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to manifest the desire of Ormoc City, Philippines, to have a sisterhood relation with the City of Long Beach, California, United States of America; and be it

"RESOLVED, FURTHER, that copies of this resolution be furnished His Honor, the Mayor, City of Long Beach, through Dr. Oscar Domondon, 9714 Atlantic Avenue, Long Beach, California, U.S.A. 90807; and His Excellency, the U.S. Ambassador to the Philippines, U.S. Embassy, Roxas Boulevard, Metro Manila;
