RESOLUTION NO. 1497

A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE NATIONAL OIL CO.,  
(PNOC) TO MAKE CABINGTAN ROAD PASSABLE AGAIN AVAILING ITSELF  
OF ITS HEAVY EQUIPMENT IN RESTORING THE PASSABleness OF THE ROAD

"WHEREAS, this august Body will recall that thousands and thousands of pesos have been expended by the City for the construction and maintenance of the Cabingtang barangay road only to be found out now that it has become impassable and abandoned by the Philippine National Oil Company who used to widen and sort of improve this road for purposes of field operations but could not go on for reasons only known to the company;

"WHEREAS, the barangay folks of Cabingtang and neighboring area have asked for the intercession of this august Body with the PNOC for the latter to restore the road to passableness considering that they are the most responsible for the unusability of said road and that they have the necessary equipment for this project;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Philippine National Oil Co. (PNOC) to make Cabingtang road passable again availing itself of its heavy equipment in restoring the passableness of the road; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Engr. Ernesto B. Patanao, Project Manager, PNOC, the City Engineer, and the Punong Barangay of Cabingtang, all in Ormoc City;

"CARRIED UNANIMOUSLY."
