RESOLUTION NO. 1503

A RESOLUTION PROHIBITING OR INHIBITING THE CONSTRUCTION OF  
"ABONGS" AND ANY OTHER DEVICES THAT OBSTRUCT MOVEMENTS  
OF SMALL FISHERMEN, SEA BATHERS, PICNICKERS, AND OTHERS  
ALONG THE COASTAL WATERS OF ORMOG CITY.

"WHEREAS, small fishermen, sea bathers, picnickers and others cannot fully enjoy their day at the beach because of the existence of fishtraps locally called 'abong' specially in Barangay Linao to where people go on weekends to bathe and swim bringing along their lunches;

"WHEREAS, these 'abongs' are a menace to prawn and bangus fries which under the law ought to be protected and these constructions should, therefore, be demolished not only for the propagation of fries but also for the free movements of small fishermen, sea bathers, picnickers and the like in our beaches and future constructions should be prohibited not only in Barangay Linao but also in all the other coastal waters within the territorial jurisdiction of Ormog City;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to prohibit or inhibit the construction of 'abongs' and any other devices that would obstruct the movements of small fishermen, sea bathers, picnickers and other people along the coastal waters of Ormog City; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Punong Barangays of Macabug, Danhug, San Antonio, Ipil, Bantigue, Camp Downes, Can-adieng, Buenavista, Barangay I, Alegria, Batuan, Punta, Linao, Naungan, Lao, and San Juan, all in Ormog City;

"CARRIED UNANIMOUSLY."
