RESOLUTION NO. 1504

A RESOLUTION TO GRANT THE REQUEST OF THE PROPRIETOR, VALENCIA SPORTS CENTER, TO HOLD A 3-DAY "PINTAKASI" (FEB. 9-11) IN CONNECTION WITH THE 1984 BARANGAY FIESTA CELEBRATION SUBJECT TO THE RULES AND REGULATIONS OF THE PHILIPPINE GAMEFOWL COMMISSION.

"WHEREAS, Mr. Edgar C. Codilla, proprietor of the Valencia Sports Center, has requested a resolution to authorize him to hold a 3-day 'pintakasi' on February 9, 10 and 11, in connection with the celebration of the annual barangay festival of Valencia;

"WHEREAS, 'pintakasi' or cockfighting is a favorite Filipino pastime such that tradition dictates that any fiesta specially in the rural areas should be celebrated with cockfights among all other highlights of the jubilation; within the bounds of law, nevertheless;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded jointly by Mga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to grant the request of the proprietor of the Valencia Sports Center and do, as this Body hereby does, authorize him to hold a 3-day 'pintakasi' at the said center on February 9, 10 and 11, 1984, subject, however, to the rules and regulations promulgated by the Philippine Gamefowl Commission; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Philippine Gamefowl Commission, Tacloban City; the Station Commander, Integrated National Police, the City Treasurer, and the Proprietor (Mr. Edgar C. Codilla), Valencia Sports Center, all in Ormoc City;
