RESOLUTION NO. 1505

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXTEND THE  
DEADLINE FOR CITY MAYOR'S PERMIT AND CITY LICENSE FEE PAYMENTS,  
UPON RECOMMENDATION BY THE CITY TREASURER, FROM JANUARY 20 TO  
JANUARY 31, 1984

"WHEREAS, the deadline for payment of Mayor's permit and city li-  
cense fees is just around the corner and quite a number of taxpayers  
have made representations for its extension even just up to the end of  
the month to give them more than ample time to meet the various require-  
ments such that we find it quite proper to temporarily suspend the ope-  
ration of Section 1.s.1.4 of Tax Ordinance No. 1, otherwise known as  
the 'Ormoc City Revenue Code of 1977', to accommodate such request as  
recommended by the City Treasurer;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded jointly  
by Mga Kagawad Besabella and Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to extend the  
deadline for payment of Mayor's permit and city license fees from  
January 20 to January 31, 1984: PROVIDED, However, That the City Trea-  
surer shall have recommended the necessity for such extension; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the City Treasurer and his City License Clerks, Ormoc City;

"CARRIED UNANIMOUSLY."
