RESOLUTION NO. 1510

A RESOLUTION TO NOMINATE THE HONORABLE VICE-MAYOR JOSE C.
AVILES FOR DRAFTING BY THE PROVINCIAL DIRECTORATE IN THE
KBL SLATE FOR ASSEMBLYMEN OF LEYTE
IN THE 1984 ELECTIONS

"WHEREAS, this august Body on June 7, 1983, unanimously approved Resolution No. 1398 earnestly requesting the then Regional Directorate, through the Chairman, the Honorable Ambassador and Leyte Governor Benjamin T. Romualdez, to kindly consider the inclusion of at least an Ormocanon in the KBL slate for assemblymen in the 1984 elections taking into account the ever-growing population of Ormoc which then was 115,000;

"WHEREAS, we would like to reiterate our request for an Ormocanon to be drafted in the KBL ticket, this time, nominating the Honorable Vice-Mayor Jose C. Aviles who is the popular choice of not only the people of Ormoc but also of the neighboring municipalities;
