RESOLUTION NO. 1512

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE DONATION OF 8 FLOURESCENT AND 2 MERCURY LAMPS BY THE SALVACION BARANGAY SANGGUNIANG FOR INSTALLATION ON ELECTRIC POSTS IN THE SAID BARANGAY PROVIDED THEY DO NOT EXCEED THE ALLOWABLE 250 WATTS, OTHERWISE, ANY EXCESS SHALL BE SHOULDERED BY THE BARANGAY, INCLUDING THEIR MAINTENANCE OUT OF THE 10% REALTY TAX SHARES AND/OR ANY OTHER SOURCE OF THE BARANGAY FUND.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Torrevillas, seconded by Kagawad Bandalan;

"RESOLVED, to authorize the Honorable City Mayor to accept the donation of eight (8) units of flourescent lamps and two (2) sets of mercury vapor lamps by the Sangguniang Barangay of Salvacion for installation on electric posts in the said barangay: Provided, However, that they do not exceed the 250 watts allowed for each barangay, pursuant to Resolution No. 1149 dated April 20, 1982, otherwise any wattage in excess thereof shall be shouldered by Barangay Salvacion, including their maintenance out of the ten percent (10%) realty tax shares accruing to Barangay Salvacion and/or any other source of fund of the same barangay; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Engineer, the Sangguniang Barangay of Salvacion, and the General Manager, LEYECO V, all in Ormoc City;

"CARRIED UNANIMOUSLY."
