RESOLUTION NO. 1516

A RESOLUTION TO APPROVE THE REQUEST OF THE MANAGEMENT OF  
HOTEL DON FELIPE TO DEVELOP AND MAINTAIN AT THEIR EXPENSE  
A DRIVEWAY AND GARDEN IN FRONT OF THE NEW HOTEL BUILDING

"WHEREAS, Mrs. Victoria L. Locsin, manager of Hotel Don Felipe, in her letter of January 18, 1984, had requested approval for them to develop and maintain at their expense a driveway and garden in the area fronting the new hotel building, which communication was referred to the City Engineer for comment; with the driveway layout;

"WHEREAS, the City Engineer in his return indorsement of January 25, 1984, indicated in red ink on the driveway layout the property line where no building part should go beyond, per Chapter 10, Section 1001 of Presidential Decree No. 1096, and also enclosed therewith forms for the hotel management to accomplish;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly by Mga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to approve the request of the management of Hotel Don Felipe to develop and maintain at their expense a driveway and garden in front of the new hotel building; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Development Coordinator, and Mrs. Victoria L. Locsin, Manager, Hotel Don Felipe, all in Ormoc City;

"CARRIED. Eight affirmative votes; one abstention registered by Kagawad Larrazabal."
