RESOLUTION NO. 1517

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, TO SIGN THE DEED OF SALE EXECUTED IN FAVOR OF THE CITY GOVERNMENT OF ORMOC BY THE SALA BROTHERS AND SISTERS REPRESENTED BY THEIR ATTORNEY-IN-FACT AND SISTER, MRS. FE SALA VILLARICA COVERING 25 SQUARE METERS PORTION ON LOT NO. 704 AND 57 SQUARE METERS ON LOT NO. 705 AFFECTED BY THE WIDENING OF MABINI STREET AT THE RATE OF P200.00 PER SQUARE METER.
