RESOLUTION NO. 1526

A RESOLUTION TO DIRECT THE CITY ASSESSOR TO CANCEL TAX DECLARATION NO. 62580 IN THE NAME OF THE CITY GOVERNMENT FOR LOT NO. 862 AND TRANSFER SAID DECLARATION IN FAVOR OF TEOTIMA AND CRESCENCIO AGCANG, THE REAL OWNERS AND ACTUAL POSSESSORS OF THE LAND OF 239 SQUARE METERS SITUATED IN CARLOS S. TAN STREET.

"WHEREAS, Teotima and Cresencio Agcang, by their counsel, Atty. Pastor T. Balugo, in a letter dated January 2, 1984, have requested a correction of the mistake inadvertently made by the City Government (City Assessor's Office) in issuing Tax Declaration No. 62580 of Lot No. 862 in its favor covering 239 square meters situated in Carlos S. Tan Street instead of Teotima and Cresencio Agcang, the real owners and actual possessors of the land for more than 30 years now;

"WHEREAS, in a conference with the Committee on Public Properties it was agreed that the City Government will waive its right over Lot No. 862 and, for taxation purposes, the same will be declared in favor of Teotima and Cresencio Agcang who will then pay their taxes in arrears;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Tugonon; be it

"RESOLVED, to direct the City Assessor to cancel Tax Declaration No. 62580 in the name of the City Government for Lot No. 862 of 239 square meters situated in Carlos S. Tan Street and transfer said declaration in favor of Teotima and Cresencio Agcang, the real owners and actual possessors of the land; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Assessor, the City Treasurer, and Teotima and Cresencio Agcang, through their counsel, Atty. Pastor T. Balugo, Balugo Law Office, 2nd Floor, Rosalia Building, Cor. Real-C. Aviles Streets, all in Ormoc City; "CARRIED UNANIMOUSLY."
