A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST THE

51/100 PESOS (P19,925.51) TO SETTLE OUTSTANDING OBLIGATIONS  
WITH THE GOVERNMENT PRINTING OFFICE INCURRED IN 1976
