A RESOLUTION EXPRESSING OUR DESIRE TO HAVE A SISTERHOOD  
RELATIONSHIP WITH SAN CARLOS CITY, NEGROS OCCIDENTAL

"WHEREAS, the Honorable City Mayor has forwarded to us the letter dated February 14, 1984, of Director Gaudioso C. Sosmeña, Jr., of the Bureau of Local Government Supervision informing that the Philippine Sisterhood Secretariat has received a communication from the Affiliation Committee of San Carlos City, Negros Occidental, expressing their intention to establish a sisterhood relationship with Ormoc City;

"WHEREAS, we are ready, willing and able to have such sisterhood relationship with San Carlos City considering that our two cities have some interests in common such as in agriculture, trade, commerce, industry and other aspects of the economy even as both are component cities of their respective provinces;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the other Mga Kagawad; be it
