RESOLUTION NO. 1535

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL ECONOMIC DEVELOPMENT
AUTHORITY (NEDA) TO INCLUDE THE ORMOC PORT IN THEIR 1984 PORTS
DEVELOPMENT PROJECTS.

"WHEREAS, some of us in this august Body who were then Members of
the First Sangguniang Panlungsod will remember that aside from request-
ing the President to appropriate sufficient funds for the improvement
of the Ormoc wharf (Res. No. 98, s. 1976) we also requested him to ins-
truct the Philippine Ports Authority to include Ormoc in the Ports De-
velopment under the Philippine Rural Infrastructure Project (Res. No.
703, s. 1979) and, further, we requested the Philippine Ports Authori-
ty, through the Regional Director, for the expansion and improvement
of the Ormoc Port (Res. No. 745, s. 1979);

"WHEREAS, the old portion of the pier, which was constructed in
1935, is already very weak considering that the reinforcing bars are
already exposed to the elements and are already rusty and there is
danger that it may collapse anytime because of the heavy load of car-
goes stored in the pier;

"WHEREAS, whatever negligible improvement made of the Ormoc wharf
is only overshadowed by the unsightly jumble of crates and other car-
goes remaining for days from end to end with a make shift PPA outpost
in the middle, not to mention the dirt and waste materials that litter
all along, and all these in a mess constitute an eyesore to visitors
and travelers even as they pose a danger, discomfort and inconvenience
to boat passengers, pedestrians and vehicles;

"WHEREAS, we believe that it is about time that we turn our needs
to the National Economic Development Authority (NEDA) which now handles
Ports Development Projects for the inclusion of the Ormoc Port with
the view to expanding and improving the same;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded unani-
mously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the National Economic Development
Authority (NEDA), to include the Ormoc Port in their Ports Development
Projects of the year 1984; and


"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the National Economic Development Authority, Padre Faura St., Metro
Manila; the Regional Director, NEDA, Region VIII, Tacloban City; the
Officer-In-Charge, PPA, and the City Engineer, both in Ormoc City;


