RESOLUTION NO. 1537

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT  
THE CONSTRUCTION BY THE PHILIPPINE RIGID CONSTRUCTION  
CORPORATION OF THE ORMOC SHOPPING MALL, PHASE I

"WHEREAS, following the request of the Manager, Philippine Rigid Construction Corporation, for final inspection of the Project Construction of the Ormoc Shopping Mall, Phase I, in his desire to turn over the project complete as per plans, specifications and other contract requirements, the Office of the City Engineer conducted an inspection and, forthwith, recommended its acceptance;

"WHEREAS, the City Pre-Bid and Award Committee had, likewise, conducted an inspection of the same project on February 22, 1984, and, also, by its resolution of March 5, 1984, had recommended that the City Government accepts such construction;
