RESOLUTION NO. 1540

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF 4 UNITS OF MERCURY VAPOR LIGHTING FIXTURES BY THE
NASUNOGAN SANGGUNIAN BARANGAY FOR INSTALLATION AT FOUR BARAN-
GAY STREET CORNERS SUBJECT TO SP RESOLUTION NO. 1149 OF APRIL
20, 1982, ON BARANGAY WATTAGE LIMITATION

"WHEREAS, the Sanggunian Barangay of Nasunogan by its Resolution
No. 03 of February 26, 1984, has signified their intention to donate 4
units of mercury vapor lamps with accessories for installation at four
street corners of the said barangay;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded joint-
ly by Mga Kagawad Bandalan, Larrazabal and Hermosilla; be it

"RESOLVED, to approve Resolution No. 3, current series, of the
Sanggunian Barangay of Nasunogan and do, as this Body hereby does,
authorize the Honorable City Mayor to accept the donation of 4 units
mercury vapor lighting fixtures for installation at four street cor-
ners of Barangay Nasunogan subject, however, to Resolution No. 1149
dated April 20, 1982, of the Sanggunian Panlungsod limiting electric
consumption to 250 watts per barangay to be shouldered by the City,
otherwise, any wattage in excess thereof shall have to be borne by
the Barangay Sanggunian of Nasunogan out of their 10% realty tax
shares or from any other source of barangay funds; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Engineer, the City Treasurer, the General Manager and the
Board President of LEYECO V, and the Sanggunian Barangay of Nasun-
gan, all of Ormoc City;

"CARRIED UNANIMOUSLY."
