RESOLUTION NO. 1541

A RESOLUTION EARNESTLY REQUESTING THE REGISTER OF DEEDS TO CANCEL
THE ANNOTATION AT THE BACK OF T.C.T. 15386 FOR LOT NO. 2228-B
IN THE NAME OF HIGINO M. CABILING ABOUT A PREVIOUS CLAIM OF THE
CITY GOVERNMENT WHICH IS WAIVED.

"WHEREAS, Atty. Conrado S. Sabelino, Attorney-In-Fact of Mrs. Au-
rora Cabiling, in his letter dated 14 March 1984 has requested the can-
cellation of the annotation at the back of Transfer Certificate of Title
No. 15386 for Lot No. 2228-B in the name of Higinio M. Cabiling, deceased,
following our Resolution No. 1519 of February 21, 1984, requesting the
Register of Deeds to annotate the cancellation of entries at the back of
the titles of the Heirs of Alejandro Cabiling and Valentina Cabiling vda.
de Bandalan which are similarly situated about previous claims of the
City Government which are already waived;

Sabelino, all of this city;
