

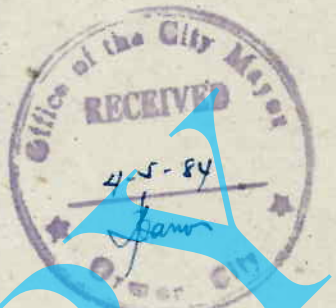

RESOLUTION NO. 1548

A RESOLUTION TO ALLOW THE ROTARY CLUB OF ORMOG CITY TO INSTALL
THEIR "FOUR-WAY TEST" SIGNBOARD RIGHT IN FRONT OF TERMINAL
BUILDING NO. 2 BETWEEN THE SIDEWALK AND THE SEAWALL ON
IMELDA AVENUE, SUBJECT TO THE APPROVAL OF THE CITY ENGINEER

"WHEREAS, the Honorable Mayor has forwarded to this august Body
the letter of the Chairman, Vocation Service, Rotary Club of Ormoc
City, requesting a space at the city plaza for installing their "Four-
Way Test" signboard as a constant reminder regarding truthfulness and
fairness in our relationship with our fellowmen;

"WHEREAS, we find it most appropriate for this signboard to be
installed right in front of the terminal building No. 2 between the
sidewalk and the seawall on Imelda Avenue if the City Engineer would
approve;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Samson and Codilla; be it

"RESOLVED, to approve the request of the Rotary Club of Ormoc
City and do, as this Body hereby does, allow the said club to install
their "Four-Way Test" signboard right in front of Terminal Building No.
2, between the sidewalk and the seawall on Imelda Avenue, subject, how-
ever, to the approval of the City Engineer; and
