A RESOLUTION TO REQUEST THE REGIONAL DIRECTOR, MINISTRY OF LOCAL GOVERNMENT, TO AUTHORIZE ORMOC CITY TO APPROPRIATE P20,000.00 OUT OF THE 20% DEVELOPMENT FUND TO BE MADE AVAILABLE FOR INSURANCE PREMIUMS ON GROUP PERSONAL ACCIDENT INSURANCE COVERAGE FOR CHIEF TANODS AND BARANGAY TANODS OF ORMOC CITY.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad present;

"RESOLVED, to request the Regional Director, Ministry of Local Government, to authorize the City of Ormoc to appropriate the sum of Twenty Thousand Pesos (P20,000.00) out of the 20% Development Fund, said sum or so much thereof as may be necessary to be made available for annual premiums on group personal accident insurance coverage for Chief Tanods and Barangay Tanods of Ormoc City; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Ministry of Local Government, Tacloban City, and the President, Association of Barangay Councils, Ormoc City;
